For non-emergency personnel

Methods and material for containment and cleaning up

Small spill

Move containers from spill area. Vacuum or sweep up material and place in a designated, labelled waste container. Dispose of via a licensed waste disposal contractor.

Move containers from spill area. Approach the release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Vacuum or sweep up material and place in a designated, labelled waste container. Avoid creating dusty conditions and prevent wind dispersal. If emergency personnel are unavailable, contain spilt material. Suction or scoop the spill into appropriate disposal or recycling vessels, then cover spill area with oil absorbent. Protective measures

Conditions for safe storage, including any incompatibilities

Store in accordance with local regulations.
